Order of Prohibition

Issued Upon Consent

WHEREAS, Michael Bedwell ("Bedwell") was employed with Merchants Bank, Jackson, AL as an Officer. Bedwell was terminated from Merchants Bank on or about April 13, 2017.

WHEREAS, the Alabama State Banking Department ("Department"), after investigation, identified facts that during Bedwell's employment at Merchants, Bedwell violated Section 5-3A-6 of the Code of Alabama;

WHEREAS, based on these facts, pursuant to provisions of Sections 5-3A-6 and 5-2A-12 of the Code of Alabama, the Alabama Superintendent of Banks ("Superintendent") has the authority to issue and publish an order to prohibit participation by Bedwell in the affairs of any Alabama State Bank or any holding company that owns an Alabama state bank ("Order");

WHEREAS, by affixing his signature hereunder, Bedwell has consented to the issuance of this Order by the Superintendent and the Department, and has agreed to comply with each and every provision of this Order, and has waived any and all rights he might have relating to this Order including, without limitation, (a) to the issuance of a notice of intent to prohibit on any matter implied or set forth in this Order; (b) to a hearing for the purpose of taking evidence with respect to any matter implied or set forth in this Order; (c) to obtain judicial review of this Order or any provision hereof; and (d) to any rights, procedural and otherwise, under Code of Alabama Section 5-2A-12 and Section 5-3A-6 or other provisions of law;

NOW, THEREFORE, before the filing of any notices, or taking of any testimony or adjudication of or finding on any issue of fact or law herein, and solely for the purpose of settling this matter without a formal proceeding being filed and without the necessity for protracted or extended hearings or testimony, and with the understanding that Bedwell does not admit any conduct which could be construed as a violation of Section 5-3A-6 of the Code of Alabama but agrees to this Order only as an effort to resolve the issues raised by the Department:

## <u>ORDER</u>

IT IS HEREBY ORDERED, pursuant to Alabama Code Section 5-3A-6 and Section 5-2A-12, that:

- Michael Bedwell is hereby and henceforth prohibited from participating in the affairs of any Alabama state bank or any holding company that owns an Alabama state bank.
- 2. Civil money penalties are not imposed by this Order.
- 3. Nothing in this Order, express or implied, shall give to any person or entity, other than the parties hereto, and their successors hereunder, any benefit or any legal or equitable right, remedy, or claim under this Order.
- 4. This Order shall be construed and interpreted in accordance with the laws of the State of Alabama.
- Each provision of this Order shall remain fully effective and enforceable until expressly stayed,
   modified, terminated, or suspended in writing by the Superintendent.
